ACADEMY TERMS AND CONDITIONS

I understand and agree that before participating in The 3 Doors Academy, I must review and accept these terms and conditions.

Program Commitment and Graduation Requirements

If accepted in The 3 Doors Academy ("the Academy"), and I choose to enroll, I understand and agree to the following:

- 1. **Program Commitment.** The Academy is a two-and-a-half-year commitment of time, energy, and financial responsibility.
- 2. Graduation Requirements.

To receive a certificate of participation, I must:

1. Attend two five-and-a-half day retreats per year over two-and-a-half years, for a total of six group retreats.

In addition to the above, in order to receive a certificate of completion, I must:

- 2. Attend five personal meetings with my mentor via Zoom/Skype video conference or over the phone, one between each of the retreats.
- 3. Participate in scheduled group video practice sessions between retreats when possible or listen to the recorded sessions.
- 4. Maintain a daily 3 Doors meditation practice and keep a practice journal [private].
- 5. Accumulate one hundred thousand *A OM HUNG RAM DZA* mantra repetitions over two years. [This practice will be introduced at the second Academy retreat.]
- 6. Complete 63 written transformations: 21 in each of three areas: personal, family/relationships, and job/community. These transformations will be documented using the prescribed Academy format to be introduced in the second Academy retreat.
- Complete at least one personal retreat each year with a total of 21 days of personal retreat by graduation. A personal retreat is no less than three-and-ahalf days spent in practice and reflection. (Personal retreats can be done at home)
- 8. Read and sign the Code of Ethics and sign the Oath of Confidentiality upon application and comply with these guidelines throughout the program.

Financial Commitments and Cancellation Policy

I understand the following obligations and policies and agree to pay all fees and costs as follows:

- 1. **Application Fee.** \$100 non-refundable application fee
- 2. Tuition costs \$9,900 to be paid over the 2 ½ year Academy training program.

- 3. Registration Deposit: \$750.00
 - 1. The registration deposit is due 30 days after receiving the acceptance letter.
 - 2. If a participant chooses not to enter the Academy after making this payment, they will receive a refund less a \$75.00 processing fee. Once the first Group Training Retreat commences, the initial deposit is non-refundable.
- 4. Six Tuition Payments: \$1525.00 each
 - 1. Each tuition payment is due 30 days prior to each of the six Group Training Retreats.
 - 2. Late payments will result in a penalty of \$25.00.
 - 3. If I am unable to attend one of the six Group Training Retreats, tuition is still due [not room and board] and arrangements must be made with my mentor to cover the missed material.
- 3. **Costs Not Included in Tuition**. I will be responsible for the following costs that tuition does not cover:
 - 1. the cost of transportation
 - 2. the cost of food and lodging at group training retreats
 - 3. any cost incurred for annual personal retreats
 - 4. the cost of any additional mentor sessions at my request that are scheduled beyond the five hour-long sessions, one between each group retreat.
- Acceptable Methods of Payment. I understand that The 3 Doors will only accept payments through its secure website. No checks, cash, or direct wire transfers are permitted.
- 5. **Financial Assistance.** There is a limited amount of tuition scholarship money available to Academy participants. For those seeking financial assistance, please email Chelsea@the3doors.org for a Request for Financial Aid Form.

Purpose of the Academy and Authorized Representations

I understand and agree to the following:

- 1. The purpose of the Academy is to provide opportunities for personal growth and development.
- 2. <u>Graduation from the Academy does not certify me to teach the practices of The 3 Doors or share them with others.</u>
- 3. Neither participating in nor graduating from the Academy makes me an agent of The 3 Doors. Thus I will **not** represent myself as an agent or teacher of The 3 Doors.
- 4. However, upon graduation, I may represent myself as a graduate of the 3 Doors Academy.

Intellectual Property Rights

I understand and agree to the following:

1. I acknowledge that The 3 Doors maintains sole and exclusive ownership of its intellectual property ("the Property"). The Property includes the wordmark, "The 3 Doors," and related design marks as well as copyrighted material presented by The

- 3 Doors representatives throughout the Academy. As Tenzin Wangyal Rinpoche has authorized The 3 Doors to act as his non-exclusive agent, the Property also includes copyrighted materials authored and owned by Tenzin Wangyal Rinpoche.
- 2. I will not use the Property in any manner that infringes on The 3 Doors' ownership rights. If I wish to use the Property, I will seek consent from The 3 Doors and only commence use upon entering a licensing agreement with The 3 Doors. If I infringe on The 3 Doors intellectual property rights, I understand that I may be subject to legal proceedings.

Oath of Confidentiality

I hereby take an Oath of Confidentiality that I will keep all materials, conversations, training exercises and/or shared experiences that I encounter during the Academy training strictly confidential. I understand any breach of this oath could result in dismissal from the program.

- 1. I understand and agree to hold in strictest confidentiality the disclosure of all personal information of my fellow trainees and teachers during my training in the Academy. If something arises that I deem potentially harmful to any participant in the Academy, I will bring this to the immediate attention of the Academy teachers.
- 2. I will not teach, proclaim, or write about the teachings, practices, or my experiences in the training without written consent from The 3 Doors.
- 3. I will not make any recordings or videos to document the teachings, practices, conversations, or materials. I understand that The 3 Doors will make recordings of teachings and practice sessions of each retreat available to all participants.

Dismissal and Right to Discontinue

I understand and agree to the following:

- 1. The 3 Doors reserves the right to dismiss me from the Academy for a reasonable cause such as failing to make tuition payments, failing to participate in a significant amount of Academy activities or graduation requirements, disrupting or endangering the well-being of the group or its individual members, engaging in an ethical violation as described in The 3 Doors Ethical Violations Policy and Procedures, breaching the oath of confidentiality, or infringing on The 3 Doors' intellectual property rights.
- 2. **Right to Discontinue.** I may discontinue my participation in the Academy at any time. However, I will be responsible for adhering to the cancellation policy and completing my tuition payments for retreats I have attended in a timely manner.

Assumption of Risk; Release of Liability

I understand and agree to the following:

1. **Assumption of Risk; Hold Harmless.** I assume all risks arising or resulting from my participation in the Program. I agree to hold harmless The 3 Doors and/or any of its

- officers, directors, teachers, employees and/or volunteers (collectively, "Personnel") from any injury or damage to myself or others.
- 2. **Release and Waiver of Liability.** To the extent permitted by law, I hereby release and waive any and all rights to sue The 3 Doors and/or any Personnel for any injury or damage that I may sustain during, or as a result of, my participation in the Program. I am fully responsible for the safety, well-being, and conduct of me and any minors I may bring to Academy retreats.
- 3. **No Substitute for Therapy or Medical Treatment.** I understand and agree that The 3 Doors and its Personnel do not diagnose or treat any medical or psychological condition and that participation in the Program is not a substitute for any medical, psychological or other therapy or treatment. However, we reserve the right to recommend additional medical or psychological treatment as a requirement for continued participation in the program.
- 4. The 3 Doors is not responsible for providing emergency medical care during retreats. If The 3 Doors determines that emergency medical services are required for me or minors under my care, I authorize The 3 Doors to arrange such care solely at my own expense.

I understand and voluntarily agree to abide by the all the above Terms and Conditions and The 3 Doors Code of Ethics and Oath of Confidentiality as a requirement for participating in The 3 Doors Academy.
